Mayor Grauerholz stated a meeting will be held on July 9th with the Chamber of Commerce and a couple of State Senators to discuss Senator McDonald's proposed study to build a dam on the Platte River. Council Member Niemeyer will represent the Council at the meeting. Grauerholz said that Allo and Windstream have both indicated they will be applying for grant money to potentially increase broadband in Ashland. He said the sidewalk program presentation went well and the program will be proceeding. He noted instituting the program will take quite a bit of office staff time. He reported on a meeting with school officials and others on their proposed construction project and bonds. He said he feels good about the traffic plan that was presented. He noted the City will be not collect building and utility fees of approximately \$250,000 from the school project. He reported on grants that may be available for roadside clean-up, recycling, scrap tire collection and household waste collection. He thanked Council Member Niemeyer and others that pulled weeds and cleaned up part of the landscaping at the Community Resource Center. He said the budget is being worked on and noted there are upcoming budget workshops. He said City staff are spraying for mosquitos.

Council Member Anderson asked about coordination of property owners replacing sidewalks and the City's contractor for the corner ramps. City Administrator Quady explained the 60 day time frame in the sidewalk program letter and that the City will work will people as each phase has three seasons. She requested that property owners keep the City informed of their repair plans. Discussion held on sidewalk assessment and program.

City Administrator Quady gave a brief update on Lesley's nuisance property.
