Quady discussed the two design price points available from CivicPlus and the annual costs. Quady noted the City of Ashland is also looking at new UB/Finance software and will be able to do both this year [financially], with some costs next year as well. Quady proposed the standard option for now, with the option available to upgrade anytime.
