## ASHLAND CITY COUNCIL REGULAR MEETING MINUTES March 6, 2025

A regular meeting of the Ashland City Council was held at the Ashland City Hall Council Chambers on the 6th day of March, 2025 at 7:00 p.m.

Notice of the meeting was advertised in the Ashland Gazette on February 28th, 2025. The Mayor and all Council Members received advance notice of the meeting and a copy of the agenda as shown by the Acknowledgment of Receipt of Notice. All proceedings shown hereafter were taken while the convened meeting was open to the public.

Mayor Anderson called the meeting to order at 7:00 p.m. The Pledge of Allegiance was recited. Roll Call was taken, and a quorum was declared. Anderson noted the Open Meetings Act located on the south wall of the room.

Public comment opportunity given. No comments made.

Mayor Anderson opened the Public Hearing on Application #24-202 for a Conditional Use Permit to construct and operate private grass runway located in Pt NW1/4 NE1/4, Pt NE1/4 NE1/4, Pt SE1/4 NE1/4 Sec 34-13-9. The property is located East of old railroad tracks between Bluejay Way and County Road A at 7:02 p.m.

Liz Flynn of 3156 Lisaje Ave spoke in opposition with concerns of stymying Ashland's growth and impact to homes. Also requested the City to have specific, rather than general, guidelines if an airport or runway were ever to be developed in the future.

Dustin & Lacy Detering of 2702 Bluejay Way spoke in opposition of a runway in close proximity to homes, school property, and future community center, and their concern of this turning into an airport over the long term.

Matt and Jenny Van Moorleghem of 1109 Bluejay Plaza spoke in opposition due to noise pollution and plane traffic.

Dave Lutton requested the council deny this as it is not a good location for an airport and requested an airport location be considered as part of the Comprehensive Plan currently being developed.

Jaime Thimm of 1106 Bluejay Plaza spoke in opposition as their plans to build and move here did not take into account what is being proposed.

Dan Beranek of Ashland, currently building in this area, spoke in opposition of having an airport or runway this close to their home.

Matt Treadway of Ashland, owner of property and applicant of conditional use permit, stated the understanding of the concerns noted. He mentioned the Millard airport, which has 60 flights per day, has not impacted the development or growth of that community. He mentioned safety during flight being his #1 concern. He predicted at most 100 flights per year and this is also weather dependent, and can limit traffic over the area as much as possible. Weather and wind conditions may result in a number closer to 50 flights per year.

Email from Kris Bousquet of Lincoln (and of 1009 Bluejay Circle as their future homesite) was read, who is in support of the project per discussion between him and Mr. Treadway. He feels the air traffic designs made by Mr. Treadway will limit noise and air traffic, with minimal impact. He also stated city accommodations for ag enterprises, which should be upheld by the City, and landowner rights should also be supported by the City. He stated no concern to his future home's property value, and this proposal has reaffirmed his decision to build and move here because of the respectful nature of Mr. Treadway and Ashland's support of agriculture.

Mr. Treadway mentioned that if he were asked to only use this for private vs. commercial use for his own spraying needs, he said he would if that were a condition of the use permit.

Shirley Niemeyer provided a handout to the Council and spoke in opposition due to future growth, pesticide drift, and noise concerns.

Mr. Treadway also mentioned that the property on the north side of the runway cannot be developed as it is in a flood plain, and also noted he would love to further educate anyone here who has doubts or concerns on this related to spraying and pesticide use.

Liz Flynn spoke again about direction of air traffic related to future development plans in the area.

With no further comment, Mayor Anderson closed the public hearing at 7:28 p.m.

Motion by Niemeyer, second by Pinkman to approve Resolution 2025-4 – Enter into an Interlocal Cooperation Agreement for the Creation of a Mutual Finance Organization.

City Administrator Quady mentioned this is an annual resolution for partnership with other villages, cities, and rural boards in the county, which allows Ashland to receive approximately \$20,000 per year.
